



ENAIRe receives the "cermi.es 2020" award for its strategy to include disabled people into the workplace

- The Jury recognises Spain's air navigation manager for its ambitious and successful workplace integration programme in the aviation industry

Madrid, 24 September 2020

ENAIRe, Spain's air navigation manager, has been presented the "cermi.es 2020" award in the category of Workplace Inclusion. The Jury for these Awards, which is presented by the Spanish Committee of Representatives for the Disabled (CERMI), wanted to highlight with this decision the "ambitious and successful general strategy of ENAIRe to include disabled people in the workplace".

In recent months, ENAIRe has entered into agreements with key players in the field and promoted the employment of people with disabilities through the subsidies it granted recently to eleven associations and foundations that work toward this goal.

In this regard, on 28 July, the State Secretary for Transport, Mobility and the Urban Agenda, and ENAIRe's President, Pedro Saura, presented ENAIRe's workplace inclusion and job creation grants for people with disabilities. At the event, which featured ENAIRe's CEO, Angel Luis Arias, and CERMI's President, Luis Cayo Pérez Bueno, he noted that the objective is to "reduce inequalities and guarantee the social and labour integration of the most vulnerable people".

The Jury concluded that, thanks to these actions, ENAIRe "is providing appropriate responses in collaboration with the third sector, taking into account the unique challenges presented by the aviation sector".

Chaired by the president of CERMI, Luis Cayo Pérez Bueno, the Jury was advised by a committee of independent experts specialising in social responsibility and sustainability, consisting of Vicky Sbenito, journalist; José Antonio Martín, representative of the Bequal Foundation; Javier de la Nava,
